TURNED IN CONFIDENTIAL INFORMATION

If you turn in any information regarding an ongoing case, or a case you may be involved in. You will be subjected to an interview by one of our lead detectives to get further information regarding your contribution. Furthermore, you will have your information checked and reviewed for full clearance of being able to be used. Under the Guardsmen Transparency Law, we refrain from confiscating information that you do not agree to let us use. (GTL issuing, Line 47) However, by agreeing to these conditions, you hereby allow us to use information you give to us, our concerns are the same as yours. To add, we follow the laws set by the JOL, primarily laws pertaining to your privacy and information. (Article 4, Line 5)

WITNESS PROTECTION

If you are to be a direct witness to a crime or an ongoing case, you will be placed under strict witness protection to ensure your safety. Under the Guardsmen Department of Protection we declared that to completely make sure you are safe, we will put you under house arrest with a neighboring Guardsmen that will check occasionally for safety assurance. You will not be charged, however you will be limited to where you can go. To agree to these terms you comply with these circumstances and fully understand and endorse our strict, but reasonable treatment. You may be subjected to questioning for evidence and to help us solve the circumstances, this will be by one of our lead detectives. If you need to go out, we will record your outing and your guard will personally drive, and or do/get what you need. This is to fully make sure you will remain safe, our guard will be positioned 24/7, possibly switched for breaks. Once you go out of witness protection, you will be let go from house arrest, and are free to live your life as normal. The JOL has agreed to these terms, and has ensured this way is deemed reasonable, both morally and lawfully. (JOL WP Meeting, 2098)

REPORTING CRIMES

If you have experienced a possible crime or happening that would require legal action we will immediately take action once notified. Under the GTL we notify you about our actions, any form of information that has been deemed to be important to let you know about. As well as providing updates to any leads or new information that has been presented to us. However, we hold the right to confiscate any information we find that is deemed too unsafe for anyone to know about besides us during our investigations. To agree to these terms you also agree to our safety protocols, and therefore agree to our rights. We prioritize your safety the most, and we respect the rights of our clients.

To agree to these conditions, you agree to all that is above.

We prioritize your safety the most, Leave no Place in Fear.
